Homeless Management Information System (HMIS) – *Cathy Kuhn*

- Outcomes
 - o Doing very well on goals exceeding all HUD goals and 2 of 3 MCoC goals
- Asking NOFA funded agencies to provide their most recently submitted APRS
- Expect the NOFA to be released before the next MCoC meeting
- Donna now has a VISTA joining her team and will be joining us next month
- HUD APR Meeting

Advocacy Updates – Kyle Beaulieu

- Federal Budget Update
 - Budget Control Act of 2011 was passed and raises the debt ceiling while requiring substantial funding cuts
 - O A Joint Select Committee (AKA SuperCommittee) of 12 congressmen will work to propose where the cuts will come over the next decade. The proposal is due by November 23rd.
 - O Congress will have until December 23rd to vote on the proposal.

 If either body fails to act, cuts will Page 2 of 3automatically be imposed at certain levels over the next decade, with 50% of the cuts coming from the defense budget and the of case of the company spending (exempting Medicare Medicard and
- other 50% coming from other discretionary spending (exempting Medicare, Medicaid, and Social Security).
- o It's likely that the majority of the cuts will not be made until FY2013.
- Federal Legislation Update
 - HR 1734, the Civilian Property Realignment Act, co-sponsored by NH's Congressman Frank Guinta (NH-1), will threaten provision V in the McKinney-Vento act that allows utilization of surplus federal property for homeless related programs.
 - HR 2441, will make its way to the House Financial Services Committee, which will abolish the National Housing Trust Fund (NHTF). Created in 2008, NHTF has never been fully funded. If fully funded, it could provide up to \$3 million to New Hampshire.
- State Legislation Update
 - A bill looks to be introduced during the 2012 legislative session that is identical to HB 368, which was scraped in the 2011 session. The bill would make workforce housing compliance optional.

- Community Awareness Committee will be working and organizing Project Homeless Connect, going forward.
- Idea:
 - O Setting up an event at the same location the night before the actual event.
 - Would be able to show our collaborative efforts/

Homeless Services Center: Update – *Dominique Rust*

- During August, the Center had on average 124 per day
- Saw 552 unique guests in August (only includes legible names)
- Chris is working on a way to circumvent illegible sign-in names
- Gathering data on homeless versus housed guests
- Chris has gone through office to make office more comfortable and functional
- Volunteer program has been significantly reviewed
- Will be posting a 20-hour a week position (12PM-4PM) so that a paid staff will always be on-sight
- Contacted St. Anslems College and will become a Service Learning Site
 - o Chris has some very interesting projects lined up
- Goodwill Industries has agreed to come to the Center for around 8-10 hours per week to provide job training skills
- Management team thanks the agencies for their continued work and help
