Homeless Management Information System (HMIS)

- Outcomes
 - 1st outcome exceeding both HUD & MCoC
 2nd outcome under HUD and under MCoC

 - 3rd outcome exceeding HUD but under MCoC
- There will be an upgrade from 4.0 to 5.0
- Submitting in an application to a foundation to help organize with resources to help launch this.
- They're looking into opportunities for the state to leverage this.
- Hoping to train providers in July and launch the newest version of the program in August.
- Started a new monthly newsletter that will be managed by the new VISTA.
 - o It will be used as a way to communicate updates in what's going on in terms of HMIS.
- 4.0 Refresher training Monday October 17 in Nashua at Harbor Homes on 45 High Street.
 - o Reminder to agency administration to notify when there is a change in staff.

SuperNOFA Grant Update

- For the exhibit 2 there were no logic models. But there is heavy emphasis on education
- HUD likes if you've identified a child in getting them back to their school of origin. It is important to demonstrate that you have policy and procedures in line with the McKinney Vento Act
- Scoring is the same as last year.
- Agencies interested in new project funding need to send an exhibit 2 in a PDF format to Susan by September 30, 2011.
- The Peer Review Committee will select winning agency by Oct 11, 2011
- This year's SuperNOFA application will be sent through e-snaps by October 18, 2011.
- In terms of the permanent housing bonus the continuum is trying to keep it at maximum 20% of services attached. The continuum is considered more competitive with more emphasis on housing.
- Data Collection committee needs Apr's for all organizations submitting exhibit 2's by Sept 23 email Cathy Kuhn.

Homeless Services Center: Update – *Craig Everett*

- During August, the Center had on average 133 clients per day and 629 unique individual clients since July 1st.

- Currently interviewing VISTA volunteers and for the Assistant Manager position.

Open Floor

- Mary Loughlin from the Food Bank emphasized how the NH Dept. of Health and Human Services is now trying to promote doing food stamp applications online. Can go to www.nheasy.nh.gov
- Comcast is providing \$10 internet a month to low income families whose children already get a free lunch at school. Can also get a \$150 coupon to get a laptop for trainings.
 - o It's not known yet how'd one access it.
